The Republic of Liberia, and Republic of Sierra Leone have received Financing from the Economic Community of West African States Commission (ECOWAS Commission) in various currencies towards the cost of the Construction of Joint Border Post at Jendenma/Bo-Waterside between Liberia and Sierra Leone. The ECOWAS COMMISSION now invites sealed bids from eligible bidders for the Construction of Joint Border Posts at Jendenma /Bo-Waterside
- 2. The erection, installation, and construction of the Joint Border Posts comprises of the followings activities:
 - a) Administration Block
 - b) Customs Brigade
 - c) Truck Inspection Area
 - d) Entry Gate Control Post
 - e) Toilet & Shower for HGV Drivers
 - f) Weighbridge; Scanner Control Rooms
 - g) Maintenance and Generator House
 - h) Fire Station
 - i) Commercial Services Building
 - j) Health Services
 - k) Pedestrian Control Zone
 - l) Veterinary Store & Animal Park
 - m) Pedestrian Toilet Block
 - n) Pedestrian Shelter
 - o) Toilet Block for LVG Public
